

OUR ACTION PLAN

The Palaszczuk Government is working to improve the management, use and enjoyment of this area, as outlined in the 10-year Daisy Hill Koala Bushland Directions Paper (2017 to 2027). The vision and direction of the Daisy Hill Koala Bushland was developed with input from a range of stakeholders following extensive planning that considered conservation, recreation and tourism needs and opportunities. Our Government continues to work with stakeholders, the local community and Traditional Owners on proposed actions in the area. This action plan details the first two stages of work, and some proposed future actions, to deliver on the vision for this iconic conservation park and community recreation hub.



PROJECT OVERVIEW

STAGE 1:

COMPLETED (2017 - 2021)

Completed projects

The following projects have been completed in the Daisy Hill Conservation Park:

- upgraded and resurfaced Ring Road
- new seating, a water station, gathering area, warm-up track and mountain-bike service area at the trail hub
- new Disability Discrimination Act compliant tracks, boardwalks, toilet blocks, picnic shelter and tables, car parks and barbecues
- new shelters and electric barbecues for day-use areas
- Paperbark Trail and walking track upgrades to improve accessibility
- new interpretive signage
- new Nature Play areas
- revitalised Daisy Hill Koala Centre
- community projects including revegetation and planting
- sustainable trail planning and work, including a full mountain bike trail audit.

STAGE 2:
\$2 MILLION
COMMENCED (2021 - 2023)



Current projects

Detailed planning is underway on the following projects for delivery between 2022-2023 in the Daisy Hill Conservation Park:

- new barrier-free paths linking the northern and southern sides of the main picnic area
- improved barrier-free access from Dennis Road to the main picnic area
- new horse float parking area and new speed tables around Ring Road
- new mountain bike trails and upgrades to existing mountain bike and walking trails
- new toilet facilities and extra car parks at the Upper Trail hub car park.

FUTURE ACTIONS
2023 >

Further stages will be developed beyond 2023

Future works and partnerships could include:

- exploring opportunities with Traditional Owners to offer services such as performance events, guided walks and storytelling sessions
- introducing new technologies to raise public awareness and understanding of conservation priorities
- further upgrades of multi-use trails, implementing outcomes of trail planning study
- road planning and re-design study and works to address safety issues associated with shared use including pedestrian and vehicular traffic.

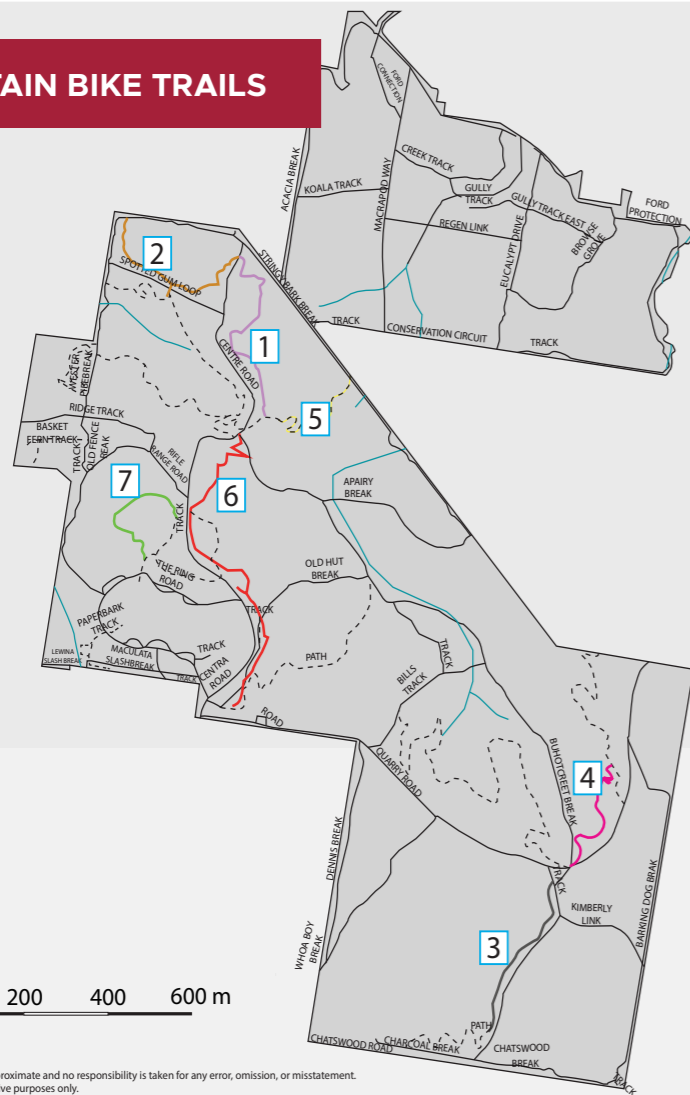
